Betty Jacqueline Veitch March 7, 1934 - September 6, 2022. Betty raised several children, held jobs outside her home, showed and coursed Borzoi and Whippets. A member of MBC since the 1970s, she served MBC as a board member and as a member of several committees, but is best known for her nearly 40 years working as the MBC lure coursing trial secretary. Betty helped start the lure coursing program for MBC. This was in the days before computers. The trial secretary had to type the premiums on a typewriter, print and mail the premiums to exhibitors. All paperwork during the trials were done by hand, and mailed to the ASFA records person. Betty was well known for her neat handwriting, her accuracy, patience, and good humor. She trained many of us to do the job of field trial clerk and field trial secretary.

AKC NEWS

Change to Lure Coursing Regulations, effective on March 1, 2023: The Board voted unanimously, to adopt a regional point schedule and only allow the point schedule to go down for those breeds/regions where it is justified. This will impact Borzois, Whippets and Rhodesian Ridgebacks in specific regions. All other breeds will remain unchanged. (No other information available).

Effective August 1, 2022. Lure Coursing. Chapter VIII. RUNNING THE MEET, TRIAL AND TEST PROGRAMS Section 6. All Stakes 9. If Best of Breed cannot be determined initially with one run, or there is more than one winner of the same stake for any of the three stakes (Open, Specials, Veteran) likely due to splits where there are higher entries, any and all winners of each stake will be randomly drawn into the Best of Breed run. The highest scoring hound will be awarded Best of Breed for that breed. High score will also be used to determine the 1st placing hound for any stake in which there was more than one stake winner prior to the Best of Breed draw. In no case will any winners of the same stake be run against each other in a runoff prior to the Best of Breed draw for the purposes of determining the top dog (overall winner) of the Open, Specials or Veteran stakes.

Effective August 1, 2022, the Virtual Scent Work Test is permanent. The AKC Virtual Scent Work Test (VSWT) aims to offer both dogs and owners a way to engage in an activity that utilizes a dog's natural ability to detect search items through self-reward and from the convenience of a home environment.

Entry Limitation for Two all-breed Shows in One Day was increased 500 to 600. This change is permanent.

Effective October 3, 2022, the Board voted to modify Chapter 3, Sections 2, 8 and 12 of the Rally Regulations to allow exhibitors who have earned the Obedience Beginner Novice (BN) title to be eligible to enter the Rally "A" classes. CHAPTER 3 CLASSES AND TITLES Section 2. Rally Novice A Class. To be eligible for entry in this class, dogs may not have won an AKC Rally Novice (RN) title or an AKC Companion Dog (CD) title or higher prior to the close of entries. A handler must own the dog entered or be a member of the owner's household or immediate family. The handler may not have previously handled any dog that has earned an AKC Rally title or an AKC Companion Dog (CD) title or higher. AKC Virtual Obedience titles do not impact the eligibility for a dog or handler in this class.

Section 8. Rally Advanced A Class. To be eligible for entry in this class, dogs must have won the Rally Novice (RN) title and may have won the Rally Intermediate (RI) title but may not have won the Rally Advanced (RA) title or an AKC Companion Dog (CD) title or higher prior to the close of entries. AKC Virtual Obedience titles do not impact the eligibility for a dog in this class. A handler must own the dog entered or be a member of the owner's household or immediate family.

Section 12. Rally Excellent A Class. To be eligible for entry in this class, dogs must have won the Rally Advanced (RA) title but may not have won the Rally Excellent (RE) title or an AKC Companion Dog (CD) title or higher prior to the close of entries. AKC Virtual Obedience titles do not impact the eligibility for a dog in this class. A handler must own the dog entered or be a member of the owner's household or immediate family.
